ORDER

The petitioners, who were arrested and remanded to judicial custody on 02.10.2024 for the offences under Sections 275, 123 of BNS-2023 r/w Section 24(1) of Cigarette and other Tobacco Products Act 2003 in Crime No.336 of 2024 on the file of the respondent police, seeks bail.

2. The case of the prosecution is that the petitioner along with other accused were in possession of 1137.5 kgs of banned tobacco products. Hence, the case.

3. Learned counsel appearing for the petitioners submitted that the petitioners are innocent and they have been falsely implicated in this case. They have not committed any offence as alleged in the FIR. He would further submit that the petitioners were arrested and is in judicial custody from 02.10.2024 and is ready to abide by any conditions that may be imposed by this Court. Hence, he prayed bail for the petitioners.

4. Learned Government Advocate (Crl.Side) opposes the grant of bail to the petitioners by stating that the petitioners along with other accused were in possession of 1137.5 kgs of banned tobacco products. He further submitted that there are no previous cases pending against the petitioners.

5. Heard both sides and perused the materials available on record.

6. Considering the representation made on both sides, nature of offence, quantity of material involved in this case, there is no previous case pending against the petitioners, taking into consideration the period of incarceration undergone by the petitioners and all other factors, this Court is inclined to grant bail to the petitioners with certain conditions

7. Accordingly, the petitioners are ordered to be released on bail on his executing a bond for a sum of Rs.10,000/- (Rupees Ten Thousand only) each with two sureties, each for a like sum to the satisfaction of the learned Judicial Magistrate Court No. 2, Kallakurichi and on further conditions that:-



[a]the petitioners shall report before the respondent police everyday at 10.30 a.m until further orders.

[b] the petitioners shall attend in accordance with the conditions of the bond;

[c] the Petitioners shall not commit any offences of similar to the offence of which he is accused, or suspected, or of the commission of which he is suspected;

[d] the Petitioners shall not, directly or indirectly, make any inducement, threat or promise to any person acquainted with the facts of the case so as to dissuade him from disclosing such facts to the Court or to any police officer or tamper with the evidence;

[e] the Petitioners shall not abscond either during investigation or trial;

[f] On breach of any of the aforesaid conditions, the learned Judicial Magistrate/Trial Court is entitled to take appropriate action against the Petitioners in accordance with law as if the conditions have been imposed and the petitioners released on bail by the learned Magistrate/Trial

[g] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 B.N.S.
