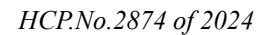

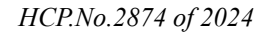
4. The alleged offence against Accused No.1 and Accused No.4 are one and the same. That being so, the detenu in the present habeas corpus petition is also to be considered on the same line.

5. In view of the fact that Accused No.4 has already been released by the Advisory Board, we are inclined to consider the present habeas corpus petition.

6. Accordingly, the detention order passed by the 2nd respondent, in proceedings C.No.48/I.T.O./IS/Tiruppur City/2024 dated 07.06.2024, is hereby set aside and the Habeas Corpus Petition is **allowed**. The detenu viz., Nayinar @ Nagenthiran, aged 48 years, S/o. Karumban confined at Central Prison, Coimbatore is directed to be set at liberty forthwith unless he is required in connection with any other case.
