ORDER

(Order of the Court was made by M.S.RAMESH,J.)

When the petitioner's son namely, R.Jeeva, aged about 29 years had gone missing, the petitioner had given a complaint on 08.08.2023 before the second respondent police. Since the petitioner's son could not be traced within a reasonable time, she has filed the present Habeas Corpus Petition.

2. Today, when the matter was called, the learned Additional Public Prosecutor submitted that on the complaint given by the petitioner, CSR No.635/2023 was given.

3. Since the second respondent has issued CSR Number, we deem it fit that the second respondent could be directed to complete the enquiry in CSR No.635/2023.
