Recording the submission made by the learned Additional Government Pleader, we dispose of the writ petition by directing the writ petitioner to make on-line application seeking Community Certificate, within one week from the date of receipt of a copy of this order and on such application being received, the second respondent shall consider the same and pass appropriate orders on its own merits and in accordance with law, within two weeks from the date of receipt of the on-line application.

4. With the above directions, this writ petition is disposed of.

There shall be no order as to costs.
