be commenced within one month from today and, thereafter, the encroachments would be removed in accordance with law expeditiously.

3. In view of the said statement, the writ petition stands disposed of. There shall be no order as to costs. Consequently, W.M.P.Nos.25591 of 2021 and 1239 of 2022 are closed. In view of the disposal of the writ petition, W.M.P.No.19587 of 2020 filed to implead the Tahsildar, Arakonam as 6th respondent is also closed.
