We have heard Mr.R.Udaya Kumar, learned counsel for the petitioner and Mr.P.Muthukumar, learned State Government Pleader for the respondents.

2. Learned counsel for the petitioner submits that there is an encroachment on the Village Road comprised in S.No.14/3A, Kolatur Kolaimedu, Redid Palayam.

3. Learned State Government Pleader submits that the authorities have already taken action. Notice under Section 7 of the Tamil Nadu Land Encroachment Act, 1905 has already been issued.

Section 6 orders would be passed within four weeks. Accordingly, steps would be taken for eviction of encroachments.
