3. In the light of the narrative thus far, captioned writ petition and captioned writ miscellaneous petition are disposed of as withdrawn albeit preserving all the rights and contentions of the writ petitioner to file a

statutory appeal and a stay petition under Section 10 and 10-B of said 1905 Act. If the writ petitioner chooses to file an appeal and stay petition, the same shall be considered by R1 on its own merits and in accordance with law *de hors* this withdrawal. There shall be no order as to costs.
