2. Heard the learned counsel appearing for the petitioner and the learned Government Advocate appearing for the respondents.

Having regard to the submissions made by the learned counsel on either side and taking into consideration the limited prayer sought for by the petitioner, without expressing any opinion with regard to the merits of the case, this Court directs the second respondent to consider the petitioner's representation dated 13.10.2023 after issuing notice to the petitioner, interested parties/rival claimants/adjacent land owners of the
