ORDER

Heard Mr. T.R.Sathiya Mohan, Learned Counsel for the Petitioners, Mr. V.Ravi, Learned Special Government Pleader, who takes notice for the First Respondent, and Mr. P.Balathandayutham, Learned Counsel, who takes notice for the Second Respondent, and perused the materials placed on record, apart from the pleadings of the parties.

2. The Writ Petition has been filed for directing the First Respondent to direct the Third Respondent to hand over the possession of the Samathuvapuram house bearing No. 61, Samathuvapuram, Pallipattu, Virdhachalam Taluk, Cuddalore District to the Petitioners.
