3. In furtherance to the order dated 08.12.2023 passed by this Court, it is informed that the First Respondent by proceedings in Na. Ka. No. 57/ Kanimam/2023 dated 20.02.2024 has passed orders to that effect and its copy has been placed on record. In view of the same, nothing remains for further consideration in the Writ Petition, but if the Petitioner still has any grievance to be redressed in the matter, he is not precluded from working out his rights before the proper forum in the manner recognized by law.

In fine, the Writ Petition is disposed with the aforesaid observations. No costs.
