2.The petition seeking leave to sue in the above Original Side Appeal is **allowed** without prejudice to the rights of the respondents.

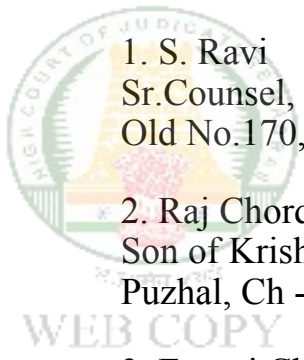

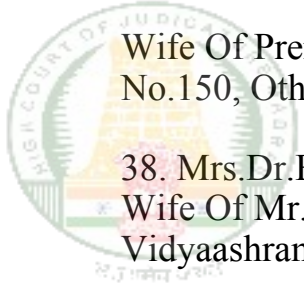
