Even according to the petitioner, the above said Nilaviyal Padhai (pathway) and Vandi Padhai (Cart Track) are situated adjacent to his patta land. Therefore, the respondents are directed to lay public road only in Nilaviyal Padhai (pathway) and Vandi Padhai (Cart Track)
