Today, the matter is listed under the caption “for being mentioned” as it was reported that few inadvertent errors had crept in, in the final order dated 13.12.2024.

2.In Para No.19 of the order, it has been wrongly typed as “Order 47 Rule 1 of CPC”



instead of “Order 7 Rule 11 of CPC” at two places. Therefore, the phrase “Order

1 of CPC” occurring at two places in Para No.19 of the order shall be replaced with

“Order 7 Rule 11 of CPC”.
