She is a Non-permanent Economics Teacher and as such she requested to make her as permanent teacher in the 4th respondent school as Economics Teacher. It is seen that the petitioner is working as teacher in a private school on temporary basis. Hence, the prayer sought for by the petitioner cannot be considered by any authority, since the petitioner has not been appointed through any recruitment agency. Therefore, the petitioner's representation cannot be considered.
