Prayer: Writ Petition is filed under Article 226 of the Constitution of India, to issue a Writ of Mandamus, directing the 1st respondent to take action against the 6th respondent (ISFC Ashok Nagar) for voluntarily and compulsorily giving loan for exorbitant interest without even disclosing the same at the first instance to the borrowers particularly the petitioners and secure the original documents of the petitioner related to his land in Arakandanallur and handover the same to the petitioners by conducting due enquiry and arriving at a reasonable amount after deducting the 28 lakhs already paid by the petitioner towards the loan amount of Rs.40,50,000/- (Rupees Forty Lakhs and Fifty Thousands only).
