This Criminal Original Petition has been filed to quash the charge-sheet in C.C.No.6613 of 2023 on the file of the Metropolitan Magistrate, Special Court for CCB/CBCID Cases, Egmore, Chennai in Crime No.202 of 2021 on the file of the first respondent/Police.

2. Today, when the matter was taken up for hearing, the learned counsel appearing for the petitioners as well as the learned counsel appearing for the second respondent/*de-facto* complainant submitted that both the petitioners and the *de-facto* complainant agreed to settle the matter amicably as the second respondent/*de-facto* complainant is not pressing the complaint given against the petitioners.
