ORDER

This writ petition has been filed seeking a mandamus directing the respondents to consider the petitioner's representations dated 10.07.2017 and 14.06.2023, wherein and whereby he sought to cancel Patta No.115 stands in the name of Pappaiah S/o.Gopichinnasamy, in respect of the

2. Today, when the matter was taken up for hearing, the learned Government Advocate appearing for respondents 1 to 5 submitted that the second respondent has already considered the representations of the petitioner dated 10.07.2017 and 14.06.2023, respectively and passed appropriate orders on 25.01.2024 and the same was uploaded through online. Based on that, revenue records were also mutated. The learned Government Advocate also produced the order of the second respondent herein dated 25.01.2024 to that effect and submitted that nothing survives for adjudication in this writ petition.

3. At this juncture, the learned counsel for the petitioner submitted that so far, the petitioner has not received the order copy. Since the learned
