This Contempt Petition has been filed for wilful disobedience of the order passed by this Court in W.P.No.14109 of 2018 dated 07.09.2023.

2. Learned counsel for the petitioner would contend that the 2nd respondent, in complete disobedience of the Government Orders, the order of this Court and the Circulars issued by the State Government, have started construction of the Vinayagar Temple within the Government premises. Learned counsel for the petitioner would specifically contend that as per the direction of the Division Bench of this Court, inspection was conducted and only on the date of inspection,
