Apprehending arrest in connection with Crime No.542 of 2024 registered for the offence punishable under Section 303(2) of BNS, 2023, the present petition has been filed seeking anticipatory bail.

2. The case of the prosecution is that the petitioner is running a company under the name and style L & T, Casting Yard. On 28.10.2024, the defacto complainant found that out of 12 tyres, 6 tyres worth Rs.70,000/- which were kept in an open space inside the company, were missing. Hence the case.

3. Pleading innocence on the part of the petitioner, false implication in the case, learned counsel for the petitioner seeks indulgence of this court. He would further submit that the petitioner is ready to abide by any stringent condition that may be imposed by this Court.

4. The case of the prosecution as putforth by the learned Government Advocate (Criminal Side) appearing for the respondent police, is that, the disk, along with tyres were stolen from the defacto complainant's company. Subsequently, 4 tyres have been recovered. He would submit that the petitioner

was not arrested during investigation, and an absconding charge sheet has been filed and the final report has been filed in C.C.No.518 of 2024, before the learned Judicial Magistrate-II, Poonamallee.

5. Having heard the learned counsel for the petitioner, the learned Government Advocate (Criminal Side) for the respondent Police and perused the materials available on record, this court is inclined to grant anticipatory bail to the petitioner with certain conditions.

6. Accordingly, the petitioner is ordered to be released on bail in the event of arrest or on his appearance, within a period of fifteen days from the date on which the order copy made ready, before the learned **Judicial Magistrate II, Poonamallee**, on condition that the petitioner shall execute a bond for a sum of **Rs.15,000/- (Rupees Fifteen Thousand Only)** with two sureties, each for a like sum to the satisfaction of the respondent police or the police officer who intends to arrest or to the satisfaction of the learned Magistrate concerned, failing which, the petition for anticipatory bail shall stand dismissed and on further condition that:

[a] the petitioner and the sureties shall affix their

photographs and Left Thumb Impression in the surety bond and the Magistrate may obtain a copy of his Aadhar card or Bank pass Book to ensure their identity;

[b] the petitioner shall report before the learned Judicial Magistrate II, Poonamalle, on all working days at 10.30 a.m., for a period of two weeks and thereafter, on the dates to be fixed by the learned Judicial Magistrate;

[c] the petitioner shall not tamper with evidence or witness either during investigation or trial;

[d] the petitioner shall not abscond either during investigation or trial;

[e] On breach of any of the aforesaid conditions, the learned Magistrate/Trial Court is entitled to take appropriate action against the petitioner in accordance with law as if the conditions have been imposed and the petitioner released on bail by the learned Magistrate/Trial Court himself as laid down by the Hon'ble Supreme Court in **P.K.Shaji vs. State of Kerala [(2005)AIR SCW 5560]**;

[f] If the accused thereafter absconds, a fresh FIR can be registered under Section 269 of B.N.S.
