2. Ms. Akila Rajendran, learned Government Advocate takes notice for the second respondent.

3. In view of the consent expressed by the learned counsel appearing for the petitioner and learned Government Advocate, this petition is taken up for final disposal.

4. The case of the petitioner is that the petitioner had completed her X, XII, B.Com and MBA in the years 2011, 2013, 2016 and 2018, respectively. The father's name of the petitioner is Mr.Kalaiselvam, but it was wrongly mentioned as Kalimulla in all her certificates. Hence, the petitioner has made a representation dated 30/9/2024 to all the respondents. Since the same has not been considered so far, she has come forward with the present writ petition praying for the relief as stated therein.

5. The learned counsel for the petitioner submits that it would be suffice if this Court issues direction to the second respondent to consider the petitioner's representation dated 30/9/2024 and pass orders on the same, within a particular time frame fixed by this Court.

6. The learned Government Advocate has no objection for the said order being passed and she fairly conceded that the petitioner's representation dated 30/9/2024 will be considered and appropriate orders will be passed within the time stipulated by this Court.

In view of the aforesaid submissions, this Court without expressing any opinion on the merits of the case directs the second respondent to consider the petitioner's representation dated 30/9/2024 on merits and in accordance with law and pass appropriate orders, within a period of one month from the date of receipt of a copy of this order.
