3. Learned Government Advocate (Crl.Side) submitted that the petitioner/ Umamaheshwari (A4) is regularly complying with the conditions imposed by this Court and the investigation is completed, final report yet to be filed.

Considering the submissions of both sides and the nature of offence, the condition No.7(a), imposed on the petitioner/ Umamaheshwari in Crl.O.P.No.23740 of 2024 on 03.10.2024, is **modified** to the effect that **the petitioner/ Umamaheshwari shall report before the respondent police on first Saturday at 10:30 a.m. of every month, until further orders.**

5. Considering the submission and endorsement made by the learned counsel appearing for the petitioners, this criminal miscellaneous petition, with regard to the 1st petitioner/ Sivangnanadhasan @ Sivagnanasambantham (A3) is dismissed as withdrawn.
