When the matter was taken up for hearing today, the learned Government Advocate (Crl.Side) appearing on behalf of the respondent submitted that the Deputy Commissioner of Police, Mylapore District through communication dated 12.01.2024 has informed the Joint Director of the Bureau of Immigration that the lookout circular issued against the petitioner is being withdrawn in view of the stay of investigation by this Court in Crl.OP.No.21043 of 2023.
