2. Learned Additional Government Pleader appearing for the appellant Department fairly stated that the Writ Court, by order dated 16.09.2010, has directed the appellant Department to regularize the services

of the respondent, on completion of ten years of total service and also to pay monetary benefits to the respondent herein. He further states that the said order passed in WP No.4639 of 2007 dated 16.09.2010 has been complied with by the appellant Department and the respondent herein has been regularized with effect from 18.03.1998.
