**Prayer:** Writ Petition filed under Article 226 of the Constitution of India praying to issue a Writ of Certiorarified Mandamus, calling for the records pertaining to the election notification issued by the 2nd Respondent on 17.09.2018 in so far as the election to elect the members / office bearers of the Board of Directors of the Kallakurichi Cooperative Sugar Mills Ltd - Unit-2, Kachirapalayam and the list of final valid nominations published by the 3rd Respondent on 09.10.2018 and quash the same as arbitrary and against of principle of natural justice and against of Article 14 and 21 of the Constitution of India and consequently direct the Respondents 1 to 3 to conduct a fair and free election for the Kallakurichi Cooperative Sugar Mills Ltd. - Unit-2, Kachirapalayam afresh, within a specified time, by accepting petitioner's nomination and



allowing the petitioner to contest the election and take appropriate action against the 3<sup>rd</sup> respondent for having violated the rules and procedures and for having accepting the nominations of respondents 4 to 30 in illegal manner and for illegal rejection of the petitioner's nomination.
