3. According to the petitioners, the 5th respondent has made encroachments in the property in question. Considering the limited scope of the prayer, without going into the merits of the case, we direct the 4th respondent to consider the representation of the petitioners dated 17.10.2023 and pass orders on merits and in accordance with law after providing opportunity to the petitioners as well as to the fifth respondent or any other aggrieved persons, within a period of twelve weeks from the date of receipt of a copy of this order.
