### **ORDER**

The Petitioner had filed this Writ Petition seeking direction to the Respondents No.1 to 3 to permit him to conduct the "Adal Padal" Programme with regard to "Pongal Festival" of Arulmigu Sri Muthalamman Thirukovil at Mamsapuram Village, Srivilliputhur Taluk, Virudhunagar District on the basis of representation given on 24.12.2023.

2. The learned Additional Public Prosecutor submitted that based on the representation, a Peace Committee meeting was conducted by the Tahsildar, Srivilliputhur Taluk, Virudhunagar District. In the Peace Committee meeting, the rival parties along with the Petitioner herein agreed that all the Temple festival connected programme may be conducted without any law and order problem and there shall not be any

"Adal Padal "programme. In this connection, the Petitioner along with the rival parties had signed the report of the Peace Committee meeting.

3. Therefore, the learned Additional Public Prosecutor submitted that as per the terms of the Peace Committee meeting, the Temple festival may be conducted without "Adal Padal" Programme.

4. In view of the above, this Writ Petition is disposed of except for conducting the "Adal Padal" programme. No costs.
