ORDER

The Petitioner had filed this Writ Petition seeking direction against the Respondents No.1 to 3 not to harass the Petitioner.

2. The learned Additional Public Prosecutor submitted that a summon had been served on the Petitioner and the fourth Respondent, but, both of them had not appeared before the third Respondent. The learned Additional Public Prosecutor on instruction from the Respondents No.1 to 3 submitted that based on the circular of the Director General of Police, TamilNadu (Head of State Police), the Respondents No.1 to 3 undertakes to hold appropriate enquiry. Since the third Respondent had issued summon, the Petitioner and the fourth Respondent are directed to appear before the third Respondent. As per the guidelines issued by the Hon'ble Supreme Court in the case of ***Lalitha Kumari Vs. State of Uttar Pradesh*** reported in ***(2014) 2 SSC 1***, the third Respondent is directed not to summon the Petitioner or the fourth Respondent at odd hours
