COMMON ORDER

Crl.O.P (MD) No.2522 of 2022 has been filed to quash the FIR in Crime No.81 of 2017 pending investigation on the file of the first respondent police.

2.When the matter was taken up for hearing, the learned Government Advocate submitted that the investigation was completed and police report was filed before the Special Court for the exclusive trial of PCR cases, Sivagangai, and the case is now pending in Special S.C.No.42 of 2023.

3.Crl.O.P. (MD) Nos.11542 and 19767 of 2018 have been filed by A1 to A8 to quash the proceedings initiated by the petitioner in

6.All these Criminal Original Petitions are disposed of accordingly. Consequently, connected miscellaneous petitions are closed.
