2.The learned counsel for the petitioner would submit that there is a serious life threat to the petitioner and if he appear before the respondent police, the defacto complainant and his supporters will attack him for retaliation. Hence, he prayed to modify the condition.

3.The learned Government Advocate(Crl.side) appearing for the respondent police would submit that the petitioner is having six previous cases and he is a history sheeter and the respondent police has to necessarily monitor his activities, in order to prevent him from committing another crime. Therefore, he vehemently opposed to modify the condition imposed on the petitioner.

4.In view of the above submission of the learned Government Advocate (Crl.side), this Court is not inclined to modify the condition.
