JUDGMENT

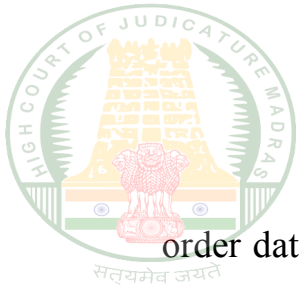
