Contempt Petition filed praying that in the circumstances stated therein and in the affidavit filed therewith the High Court may be pleased to punish the respondents herein for the willful disobedience of the order passed by this Honourable Court in W.P.(MD). No. 4065 of 2023 dated 02.03.2023.

Prayer in WP(MD). 4065/ 2023 :

To issue of Writ of Mandamus directing the respondents 4 and 5 to take action on the representation given by the petitioner seeking (a) to pay arrears in rent from 01.01.2022 till 31.01.2023 at the rate of Rs. 51,267/- with 18 percentage of interest (b) to pay the monthly rent at the enhanced rate on the 1st day of every English calendar month till date of vacating the office of the 5th respondent functioning at door no. 3/15, Medaiyandi Kovil street, KVR Thirumanamandapam, Thiruvengadam, Tenkasi District (c) to pay 18 percentage of interest for the belated payment of rent, (d) to pay the TDS amount of Rs.2,49,444/- and (e) to do the repair works as per the terms of rental agreement.
