After bifurcation of Subordinate Court and establishment of new Subordinate Court in Manamadurai, it was transferred and renumbered as O.S.No.40 of 2020. Seeking expeditious disposal of the said suit, this Civil Revision Petition came to be filed by the petitioner. Considering the oldness of the matter, a request is made by the petitioner to give a direction to the trial Court to complete the trial.
