ORDER

This Criminal Original Petition has been filed to direct the learned Special Judge for SC / ST (Prevention of Atrocities) Act / II Additional District and Sessions Judge (PCR Court), Tirunelveli, to consider the bail application of the Petitioners on the same day of their surrender in Crime No.3 of 2024 on the file of the 2nd Respondent Police.

2. The learned Government Advocate (Crl.Side) submits that the Defacto complainant warned and advised the Petitioners herein, while they are driving two wheeler in a rash and negligent manner, for which, the Petitioners are alleged to have attacked the 3rd Respondent / Defacto complainant and he suffered loss of teeth and was treated for the same, now discharged from Hospital. The Petitioners have no previous case.

3. Considering the submissions made by the learned Government Advocate (Crl.Side), this ***Criminal Original Petition*** is disposed of. The Petitioners are directed to surrender before the learned

On such surrender by the Petitioners, the learned Special Judge for SC / ST (Prevention of Atrocities) Act / II Additional District and Sessions Judge (PCR Court), Tirunelveli, shall consider the bail application of the Petitioners and dispose of the same, after issuing notice to the 3rd Respondent / Defacto complainant and after hearing their objections of the victim of the crime, pass appropriate orders as per law.
