The present Habeas Corpus Petition has been filed to direct the respondents to produce the person or body of the detainee namely R.Shivani, D/o.Ramesh, aged 21 years before this Court and set her at liberty.

2.Learned Counsel for the petitioner submitted that the petitioner and the detainee got married on 02.08.2022 and they both are majors. He further submitted that the detainee has been illegally detained by her parents and they are arranging marriage for the detainee with someone else.

3.Today, the respondent police produced the detainee before this Court. This Court permitted the petitioner and the detainee to have a word with each other as per their request. Thereafter, the detainee expressed that she wanted to go with the petitioner who is her husband.
