This Habeas Corpus Petition has been filed to direct the respondents to produce the petitioner's daughter, namely, S.Ramalakshmi, D/o.A.Sankaralingam, aged about 18 years, before this Court and set her at liberty.

2. According to the petitioner, her daughter / detenue left the home for College on 02.01.2024, but she did not return. Hence, she lodged a complaint before the third respondent. Though the third respondent has registered a case in Crime No.8 of 2024, did not take any steps to find out her whereabouts. Therefore, she has filed the present Habeas Corpus Petition.
