2.The case of the prosecution is that on 21.07.2023, on secret information, the respondent police made surprise visit at Thalapparvai, where the petitioner was found illegally transporting gravel sand. Hence the vehicle was seized and the present case was registered.

3. Learned Government Advocate (Crl.side) submitted that the petitioner has involved in a previous case in similar nature. The earlier petitions filed by the petitioner seeking anticipatory bail was dismissed. There is no change in circumstances.

4. In view of the above said submission, I find no reason to entertain this petition. Accordingly, this Criminal Original Petition is dismissed.
