file of the learned Judicial Magistrate Court No.I, Kumbakonam, Thanjavur District, in Crime No.1982 of 2021, on the file of the respondent police, seeks bail.

2.The petitioner was absent during the trial in P.R.C.No.13 of 2023 on the file of the learned Judicial Magistrate Court No.I, Kumbakonam, Thanjavur District and hence, the trial Court issued Non-Bailable Warrant against the petitioner on 25.07.2023 and the same was executed by the respondent police and the petitioner was arrested and remanded to judicial custody on 19.08.2023.

3.The learned counsel appearing for the petitioner would submit that the petitioner has been falsely implicated in this case and due to another false case has been registered against the petitioner, he is not able to appear before the trial Court. He would further submit that the petitioner is in judicial custody for more than four months. Hence, he prays for grant bail to the petitioner.

5.The learned Additional Public Prosecutor appearing for the State would submit that the petitioner is a history sheeted rowdy and 12 previous cases are pending against him. He would further submit that investigation has been completed and the charge sheet has already been filed before the concerned Court. Hence, he

strongly opposed to grant bail to the petitioner.
