The learned counsel for the petitioners would submit that the 1st petitioner was arrested on 12.08.2024, and the 2nd petitioner voluntarily surrendered before the trial Court on 29.10.2024, and both of the accused are in custody till date.

2.Since both the petitioners are already in custody, there is nothing remains to be adjudicated in the present petition.

3.Accordingly, this Criminal Miscellaneous Petition stands dismissed as infructuous.
