2. The learned counsel for the petitioners would submit that since the first petitioner is a practicing Advocate and the second and third petitioners are ladies, this Court may consider this petition.

3. Considering the facts and circumstances of this case and also considering the submissions made by the learned counsel for the petitioners, this Court is inclined to modify the condition imposed upon the petitioners that the first petitioner shall appear before the Inspector of Police, Othakadai Police Station, Madurai District for a period of one week and thereafter as and when required. The petitioner Nos.2 and 3 shall appear before the respondent Police as and when required for interrogation.
