When the matter was taken up for hearing, the learned Special Government Pleader submitted that action has already been taken and that after issuing notice under Section 7 of the Act Tamil Nadu Land Encroachment Act, 1905, final order under Section 6 of the Act was passed. If the affected parties do not obtain any interim order, the encroachment will be removed within a period of twelve weeks from the date of receipt of a copy of this order.



5. Recording the said undertaking of the official respondents given through the learned Special Government Pleader, this writ petition stands disposed of. No costs.
