ORDER

Today, when the matter is taken up for hearing, the learned Additional Government Pleader submits that it is only a temporary suspension order, based on the wrong entries made by the petitioner Sangam and pursuant to the interim order passed by this Court, the petitioner Sangam has been permitted to function and now, they have received E-form for renewal of the petitioner Sangam.
