### **ORDER**

This Writ Petition is filed, seeking for a direction to the 2<sup>nd</sup> respondent to consider the petitioner's representation dated 28.12.2023 to remove the encroachment made in the southern side of the property, situated in Ayan Ponmeni Village, Theni Road, Madurai South District and also to prevent the unlawful activities by giving safety to the public.

2.On perusal of the records available before this Court, it is seen that the petitioner has not mentioned the survey number, in which the encroachment has been made, but has impleaded the respondents 4 and 5, which has been disputed by the learned counsel appearing for the respondents 4 and 5 by stating that the
