2.When the matter is taken up for hearing the learned Government Advocate (Crl.Side) would submit that already this Court granted anticipatory bail to the petitioner in Crl.OP(MD)No.11940 of 2023 on 30.06.2023. However, the petitioner has not furnished sureties till date. Further, the investigation was completed and final report was filed before the Special Court for Land Grabbing Cases, Madurai, and the same was taken on file in C.C.No.703 of 2023.

3.This Court already granted anticipatory bail to the petitioner in Crl.OP (MD)No.11940 of 2023 on 30.06.2023. However, the petitioner has not furnished sureties. Without filing a petition for extension of time, he approached this Court, by way of filing this petition is not sustainable one.

4.Accordingly, this Criminal Original Petition is dismissed with liberty to the petitioner to file extension of time petition.
