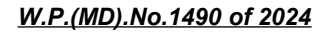

The present writ petition has been filed seeking a direction to the respondents to settle the interest for the belated payment of retirement benefits along with Gratuity, Earned Leave, Medical Leave, Provident Fund and other retirement benefits payable to the petitioner with 6 % rate of interest, within the time frame stipulated by this Court.

This shall be done within a period of twelve (12) weeks from the date of receipt of a copy of this order. There shall be no order as to costs.
