The learned Additional Public Prosecutor also submitted that as per the circular of Director General of Police, Tamil Nadu, Chennai, in Rc.007301/Genl.I(1)/2019, dated 09.04.2019 and Additional Director General of Police in C.No.18/ADGP/L&O/Camp/2024, the Field Officers throughout the State of Tamil Nadu are not to involve themselves in the civil dispute particularly involving money dispute and property dispute. The learned Additional Public Prosecutor would further submit that the Respondent Police would dispose of the current paper within a short period of time.
