ORDER

This Writ Petition is directed against the impugned interim order passed by the first respondent in Na.ka.No.T5/20955/2020, dated 11.12.2020, stayed the patta transfer order passed by the second respondent.

2. When the matter is taken up for hearing today, the learned Special Government Pleader appearing for the State would submit that the first respondent has dismissed the revision petition itself vide order, dated 25.11.2022 and thereby vacating the interim stay already granted and directed the parties to approach the Civil Court for appropriate remedies.
