4. In the light of the above, the Respondent Police are directed to issue summons as per the reported rulings of the Hon'ble Supreme Court in the case of ***Lalitha Kumari Vs. State of Uttar Pradesh*** reported in ***(2014) 2 SSC 1*** and the case of ***Arnesh Kumar Vs. State of Bihar and another*** reported in ***2014 (8) SCC 273***. The Respondents shall issue summons to the Petitioner specifying the time and date for his appearance and interrogation. On receipt of such summons, the Petitioner is directed to co-operate with the pending enquiry. The Respondents are directed not to summon the Petitioner at odd hours.
