On receipt of the said claim petition, the Joint Director of Agriculture, Melakanmai Street, Tallakulam, Madurai informed the petitioner that the claim petition submitted by the petitioner was already rejected by the Insurance Company, namely HDFC Ergo GIC Pvt. Ltd., on the ground that the claim of the petitioner was exceeds from the 5 years of average harvesting.
