JUDGMENT

[Judgment of the Court was delivered by **R.SURESH KUMAR, J.**]

In view of the order passed on 12.07.2024 in W.A.(MD)No. 1139 of 2024, where the very same impugned order has already been set aside and the matter has been remitted back, in this Writ Appeal we dispense with the issuance of notice to the respondents.

2.Against the impugned common order already a Writ Appeal in W.A.(MD)No.1139 of 2024 has been filed and that was disposed of by our order dated 12.07.2024, where we have passed the following order:

“10.In the present Writ Appeal, we are only confine to the correctness of the order passed by the Writ Court in REV.APLW(MD)No.171 of 2023, dated 30.08.2023.

11.Even though the ground, that had been raised by the appellants, who are the review applicants before the Writ Court, was in relation to the communication dated 13.04.2022 at the time of hearing the review application, it seems that on behalf of the

“that the order impugned is hereby set aside and the matter is remitted back to the Writ Court for re-consideration, where the Writ Court is requested to take up the review application and decide the same on merits and in accordance with law, of course, by allowing both the parties to put forth their cases by filing necessary supporting documents to that effect. So that a complete justice can be rendered on the issue raised in the present case.””

3.Since this is yet another Writ Appeal against the very same order arising out of REV.APLW.(MD)No.172 of 2023, this Writ Appeal also to be disposed of in the same line. Therefore, there shall be a similar order in this Writ Appeal also.

4.This Writ Appeal is ordered accordingly. There shall be no order as to costs. Consequently, the connected miscellaneous petition is closed.
