2.The learned Government Advocate (Criminal Side) appearing for the Respondents, on instructions, would submit that if the Petitioner appears before the Respondent Police, there are ready to pass appropriate orders as per the circular issued by the Director General of Police, Tamil Nadu/Head of State Police Force, Chennai-4, in Rc.No.007301/General I(I)/2019, dated 09.04.2019 is in force regarding organizing the events and cultural programme. He also seeks payment of appropriate fee for providing police protection, as per G.O.Ms.No. 139, Home (PoI.VIII) Dept. dated 04.03.2019.

The Petitioner as well as the organizer of the Kabadi meet shall pay reimbursement of Guard Charges for the Police Personnel as per G.O.Ms.No.139, Home (PoI.VIII) Dept. dated 04.03.2019. No costs.
